

Minutes of Kelk Parish Council Meeting on the 23rd November 2011 at 7.30 p.m. at Kelk Chapel Schoolrooms

Minutes of previous meeting were read and approved by Clive Askwith and seconded by Richard Holtby. They were accepted as a true record of the meeting on the 9th September 2011.

Matters Arising

Clive brought invoice for chairs and cheque written out for them.

Planning Application

Letter read out from ERYC stating that planning application for two storey extension and porch to side, alterations to out-building to form additional accommodation and erection of detached double garage to side following removal of existing at 1 New Row, Duckmutton Lane, Little Kelk has been rejected. It was rejected for the following reasons:- The proposed development by virtue of its size and design is not considered to be sympathetic and over dominates the character and appearance of the existing dwelling and surrounding area. Also the proposed conversion of the outbuilding to form additional living accommodation would result in the creating of an independent living unit detached from the original dwelling.

Also Planning Application for Installation of solar pv panels to south facing roof of existing poultry unit at Southfield Farm, Main Street, Great Kelk. Comments had to be in by 4 November, so Chairman decided that as the panel were facing open farm land they were not in a position to affect anyone, we could send form back with no objection.

Letter read from Jonathan Owen regarding future planning application for wind farms and diagram showing the size of turbines in comparison to surrounding buildings

Consultation letter read out about Dogger Bank Offshore Wind Farm with details of consultation meetings coming up.

Finances

A discussion on amount of precept for next year took place. Projected bank balance at 5 April 2011 is £1,019.59 (including £1,000 wind farm grant). It was decided to set precept at £300.00.

Letter from Driffild School to ask for donation for Twilight bus, it was decided to defer a decision until next meeting, to ask around if any Kelk children used the bus.

Wind Farm Grant (£1,000) must be spent by end of March so ideas for Diamond Jubilee party needed by next meeting.
